## **Basic Requirements 2026-2027**

Application Period – January 1, 2025 through December 31, 2025.

**Age** – Applicant must be at least 18 years of age at time of application.

<u>License</u> – Applicant must possess a valid New Jersey Driver's License.

<u>Education</u> – Applicant must be a High School graduate or have a GED or a two-year Associate Degree or higher. <u>Applicant must have completed one full year of High School Algebra or equivalent post high school algebra course with 75% minimum grade.</u> (CLEP testing will not be accepted)

<u>Jurisdiction</u> – Applicant must be a resident of Monmouth or Ocean County. Driver's License must match applicants mailing address. (No PO Box.)

<u>Aptitude Test</u> – Applicant must receive a qualifying score on aptitude test. Applicant will be notified by mail and/or Email as to time and date of testing. If an applicant does not receive a qualifying score and wishes to retake the Aptitude Test (After 3 months from the previous attempt), the Applicant will be required to pay \$30 for each additional Aptitude Test during the application period.

<u>Physical Condition</u> – Applicant must be able to perform the rigorous work of the trade and will be required to take a substance abuse screening test and physical along with background screening.

Applicants must submit all required information and documentation to the JATC in order to proceed with the application process. Applications are completed in person quarterly, on the first Thursday of March, June, September, and December, between 10 a.m. and 6 p.m. The JATC is located at the rear of the building, through the side door, downstairs in the first classroom on the left.

☐ 5. Must provide <u>official</u> High School transcripts showing courses and grades. Transcripts will only be considered official when received directly from the school or contain a legible raised seal and so marked.
